NOTES

1. If you intend that only your spouse or civil partner receives the grant payable there is no need to complete this form. The Scheme Regulations provide for your spouse/civil partner to automatically receive the death grant when there is no other nomination.
2. You should ensure that the SPPA is advised of any change in your nominee's contact details. It is your responsibility to ensure that all nominees are acquainted with the terms of the nomination.
3. In any case where there is no valid nomination, the death grant will be paid to your spouse/civil partner or if you have no spouse/civil partner when you die, to your legal personal representative.
4. If you have nominated two or more individuals for the death grant, you must specify the proportion that each individual is to receive. The proportions must total 100% exactly, otherwise the nomination will not be accepted as valid. If a nominee dies, the designated proportion of the death grant will be paid to your spouse/civil partner, if no spouse/civil partner the amount will be paid to your estate.
5. A nomination can be revoked at any time. If you wish to revoke your nomination, please notify the Agency in writing. If you wish to change your nomination, you should complete another Death grant nomination form. This will supersede any previous nominations.
6. In the event of a divorce or dissolution, the court has the power to make orders requiring the payment of the death grant to the former spouse/civil partner, including power to require a change of nomination.
