There will be less access to the local libraries to access information, help and support with a range of matters as well as books and a warm safe space. Staff hours will be reduced by 20% meaning staff will earn less. There will be a reduction in the time available to access IT services for job searches.

This will vary from branch to branch hence opening times may vary in order to minimise local impact. i.e. The quietest times will be identified and the reduced hours to be implemented at these times. The option for services / groups to key hold and access the space when closed / unstaffed to the public will remain in place and further assist in mitigating the impact to key groups / services using the space will remain.
