

## **The North Ayrshire Council (B714 No.1) Compulsory Purchase Order 2024**

### **The Roads (Scotland) Act 1984 and The Acquisition of Land (Authorisation Procedure) (Scotland) Act 1947**

The North Ayrshire Council incorporated under the Local Government etc (Scotland) Act 1994 and having its principal place of business at Cunninghame House, Irvine, KA12 8EE (hereinafter referred to as “the acquiring authority”) in exercise of the powers conferred by Sections 103 to 106 inclusive and 110 of the Roads (Scotland) Act 1984 hereby makes the following Compulsory Purchase Order:-

1. This Order may be cited as The North Ayrshire Council (B714 No.1) Compulsory Purchase Order 2024.
2. Subject to the provisions of this Order, the acquiring authority is hereby authorised to purchase compulsorily for the purpose of upgrading the 3.5km section of the B714 between Girthill Farm and Dalry, with other targeted on-line improvements between Diddup Farm and Girthill Farm and the construction of a new section of road between existing B714 and roundabout connection to the A737 Dalry Bypass, the land, servitudes and other rights in land which are described in the Schedule hereto (hereinafter referred to as “the schedule”) and shown on the map (comprising 4 sheets) signed with reference to this Order and marked “Map referred to in The North Ayrshire Council (B714 No.1) Compulsory Purchase Order 2024” (hereinafter referred to as “the map”).
3. In relation to the foregoing purchase Section 70 of the Railway Clauses Consolidation (Scotland) Act 1845 and Sections 71 to 78 of that Act as originally enacted and not as amended for certain purposes by Section 15 of the Mines (Working Facilities in Support) Act 1923 are hereby incorporated with the enactment under which the said purchase is authorised, subject to the modifications that references in the said sections to the company shall be construed as references to the acquiring authority and references to the railway or works shall be construed as references to the land authorised to be purchased and any buildings or works constructed or to be constructed thereon.
