

**The North Ayrshire Council  
(Various Roads)  
(Temporary Speed Restriction) Order 2019**

The North Ayrshire Council, in exercise of the powers conferred on them by Section 14(1) of the Road Traffic Regulation Act 1984, as amended by Schedule 1 of the Road Traffic (Temporary Restrictions) Act 1991 and of all other enabling powers, hereby makes the following Order :-

1. This Order may be cited as " The North Ayrshire Council (Various Roads) (Temporary Speed Restriction) Order 2019 and shall come into operation from **12<sup>th</sup> June 2019** and will remain in operation for a period of eighteen months.
2. No person shall drive any motor vehicle at a speed exceeding that displayed on a traffic sign prescribed in **Diagram 670 of the Traffic Signs Regulations and General Directions 2016** when such restriction is identified as applying to any road in the Schedule to this order by means of that sign.
